Fantasy Contest Applicants, Approvals, and Authorizations

To ensure the integrity of fantasy contests, oversight was granted to the Ohio Casino Control Commission with the passage of House Bill 132 in 2018. The Act, codified in R.C. Chapter 3774, grants the Commission jurisdiction over all those involved with fantasy contests, including the ability to license, regulate, investigate and penalize operators. The law also provides several important consumer protections.
