**ORDER DENYING CASINO GAMING EMPLOYEE LICENSE APPLICATION**

On April 19, 2018, Cha-Ronjeone Williams filed a Casino Gaming Employee License Application (“Application”) with the Ohio Casino Control Commission (“Commission”). Thereafter, the Commission conducted Williams’s suitability investigation to determine his eligibility for such a license.

An applicant is eligible for licensure as a Casino Gaming Employee upon meeting the following criteria: (1) being at least 21 years of age, R.C. 3772.131(C); (2) filing a true and complete Application, R.C. 3772.131(D) and Ohio Adm.Code 3772-8-02(A); (3) submitting two sets of fingerprints and a photograph, R.C. 3772.131(E); (4) paying the nonrefundable application fee, R.C. 3772.131(E) and Ohio Adm.Code 3772-8-03, and all fees necessary to cover the cost of the background investigation in excess of the application fee, Ohio Adm.Code 3772-8-03(B); (5) reimbursing the costs for the background check, including the criminal-records check, R.C. 3772.07 and 3772.131(E); (6) not having been convicted of or pled guilty or no contest to a disqualifying offense, R.C. 3772.07 and 3772.10(C)(1); and (7) otherwise being suitable and eligible for licensure, R.C. 3772.10(B) and (C)(7).

During the investigation, the Commission discovered sufficient derogatory information to warrant issuance of a Notice of Opportunity for Hearing (“Notice”), dated September 20, 2018. The Notice was sent via certified mail, return receipt requested, but was returned to the Commission marked “Unclaimed” on October 30, 2018. The Commission re-sent the Notice on November 1, 2018, via ordinary mail with a certificate of mailing. The Notice was not returned to the Commission for failure of delivery.

Pursuant to R.C. 119.07 and 3772.04, Williams had the right to a hearing if requested within 30 days of the Notice’s mailing. Williams failed to do so. Accordingly, no hearing was held, and the matter was brought before the Commission on January 16, 2019, for final adjudication. R.C. 119.07 and 3772.04(A).

**WHEREFORE**, in consideration of the foregoing and upon a quorum and majority vote of the members, the Commission **FINDS** and **CONCLUDES** as follows:

- 1) Williams is ineligible for licensure because he submitted an Application that contained false information or that failed to set forth all of the information required by the


Commission, in violation of R.C. 3772.10, 3772.131, Ohio Adm.Code 3772-8-02, or 3772-8-05; and

- 2) Williams failed to establish, by clear and convincing evidence, his suitability for licensure, as required by R.C. 3772.10 or Ohio Adm.Code 3772-8-05.

**WHEREFORE**, in consideration of the foregoing and upon a quorum and majority vote of the members, the Commission **ORDERS** as follows:

- 1) Williams's Application is **DENIED**.
- 2) Williams is **PROHIBITED** from working or otherwise serving in any capacity that requires a license under R.C. Chapter 3772.
- 3) Williams is **PROHIBITED** from reapplying for licensure under R.C. Chapter 3772 for three years from the date the Order is served upon his, absent a waiver granted by the Commission commensurate with Ohio Adm.Code 3772-1-04.
- 4) A certified copy of the Order shall be served upon Williams, via certified mail, return receipt requested, and his counsel of record, if any, via ordinary mail.

**NOTICE OF APPEAL RIGHTS**

The Party is hereby notified that pursuant to R.C. 119.12, the Commission Order may be appealed by filing a Notice of Appeal with the Commission setting forth the Order that the Party is appealing from and stating that the Commission's Order is not supported by reliable, probative, and substantial evidence and is not in accordance with law. The Notice of Appeal may also include, but is not required to include, the specific grounds for the appeal. The Notice of Appeal must also be filed with the Franklin County Court of Common Pleas in accordance with R.C. 119.12. In filing the Notice of Appeal with the Commission or Court, the filing may be either the original Notice of Appeal or a copy thereof. The Notice of Appeal must be filed within 15 days after the date of mailing of the Commission Order.
