

**OHIO CASINO CONTROL COMMISSION**

**RESOLUTION 2015-04**

**CONSIDERATION OF CASINO GAMING EMPLOYEE LICENSE RENEWAL APPLICATIONS**

**WHEREAS**, Article XV, Section (6)(C)(4) of the Ohio Constitution created the Ohio Casino Control Commission (“Commission”) to ensure the integrity of casino gaming by, among other things, licensing and regulating all gaming authorized by Article XV, Section (6)(C) of the Ohio Constitution;

**WHEREAS**, R.C. 3772.09(A) prohibits, among others, any casino gaming employee from conducting or participating in conducting casino gaming without first being licensed by the Commission;

**WHEREAS**, R.C. 3772.10(B) requires, among others, casino gaming employees who are seeking licensure under R.C. Chapter 3772 to establish their suitability by clear and convincing evidence;

**WHEREAS**, R.C. 3772.131(B) authorizes the Commission to issue casino gaming employee licenses to applicants, including renewal applicants, after the Commission determines that the applicants are eligible for licensure under the rules adopted by the Commission and have paid all applicable fees;

**WHEREAS**, a casino gaming employee licensee is eligible for renewal upon meeting the following criteria:

- (A) Being at least 21 years of age, as required by R.C. 3772.131(C);
- (B) Submission of a true and complete Casino Gaming Employee License Application, as required by R.C. 3772.131(D) and Ohio Adm. Code 3772-8-02(C);
- (C) Submission, on a form provided by the Commission, of two sets of the applicant’s fingerprints and a photograph, as required by R.C. 3772.131(E);
- (D) Payment of the nonrefundable license renewal application fee, as required by R.C. 3772.131(E) and Ohio Adm. Code 3772-8-03(A), and all fees necessary to cover the cost of the background investigation in excess of this fee, as set forth by Ohio Adm. Code 3772-8-03(A), if any;
- (E) Reimbursement of the costs for the background check, including the criminal records check, as required by R.C. 3772.07 and 3772.131(E);

(F) Not having been convicted of or pled guilty or no contest to a disqualifying offense, as defined and required by R.C. 3772.07 and 3772.10(C)(1); and

(G) Otherwise is eligible for licensure, as required by R.C. 3772.10(C)(7);

**WHEREAS**, R.C. 3772.15 and Ohio Adm. Code 3772-8-02(D) require that casino gaming employee licensees undergo a complete investigation at least once every three years to ensure continued eligibility for licensure;

**WHEREAS**, the 494 casino gaming employee license renewal applicants listed in Exhibit A (“Applicants”) have submitted applications for renewal of their licenses and have been reviewed by the Division of Licensing and Investigations’ staff using established investigation protocols, including a review of the results of the criminal records checks as required by R.C. 3772.07;

**WHEREAS**, the complete suitability investigations of the Applicants conducted by the Division of Licensing and Investigations’ staff revealed no criminal history and no material personal or financial information of such a derogatory nature as to render them ineligible for licensure at this time;

**WHEREAS**, the Division of Licensing and Investigations’ staff has determined that the Applicants meet all of the eligibility requirements of R.C. Chapter 3772 and the rules adopted thereunder for licensure as casino gaming employees;

**WHEREAS**, the Director of Licensing and Investigations recommends granting the privilege of a casino gaming employee license renewal to the Applicants;

**NOW, THEREFORE, BE IT RESOLVED** by the Commission that the Applicants’ renewal applications for licensure as casino gaming employees are **APPROVED** and the Applicants licenses are hereby **RENEWED** for a period not to exceed three years from the effective date of their renewals, subject to continued compliance with R.C. Chapter 3772 and the rules adopted thereunder.

**BE IT FURTHER RESOLVED**, that Resolution 2015-04 does not in any way affect, negate, or otherwise absolve any of the Applicants from their duties to update information in accordance with Ohio Adm. Code 3772-8-04.

**BE IT FURTHER RESOLVED**, that Resolution 2015-04 does not restrict or limit the Commission’s future exercise of authority and discretion with respect to imposing additional conditions or taking further action upon any of the Applicants under R.C. Chapter 3772 and the rules adopted thereunder.
