RESOLUTION 2021-28

**ADMINISTRATIVE RULES – ADOPTION & FINAL FILE**

**WHEREAS**, Article XV, Section 6(C)(4) of the Ohio Constitution created the Ohio Casino Control Commission (“Commission”);

**WHEREAS**, R.C. 3772.03 requires or authorizes the Commission to adopt administrative rules pursuant to R.C. Chapter 119 to complete the functions stated in R.C. Chapter 3772;

**WHEREAS**, in accordance with R.C. 106.03, the Commission reviewed these rules to determine, among other things, whether they should be amended or rescinded and whether they have an adverse impact on business;

**WHEREAS**, in accordance with R.C. 121.82, the Commission evaluated and filed the rules and accompanying Business Impact Analysis with the Common Sense Initiative Office;

**WHEREAS**, R.C. 119.03 sets forth the procedure for filing amended, rescinded, and new rules;

**WHEREAS**, the Commission followed the rule-filing procedure, providing the agency with the authority to adopt the rules;

**WHEREAS**, the Commission considered the matter at its public meeting held on July 21, 2021.

**NOW, THEREFORE, BE IT RESOLVED** by the Commission that the amended, rescinded, and new rules are **ELIGIBLE** for adoption and final filing.

**BE IT FURTHER RESOLVED** that the rules are **ADOPTED** and staff is authorized and directed to **FINAL FILE** them in accordance with R.C. Chapter 119.
