RESOLUTION 2021-39

**ADMINISTRATIVE RULES – ADOPTION & FINAL FILE**

**WHEREAS**, Article XV, Section 6(C)(4) of the Ohio Constitution created the Ohio Casino Control Commission (“Commission”);

**WHEREAS**, R.C. 3772.03 requires or authorizes the Commission to adopt administrative rules pursuant to R.C. Chapter 119 to complete the functions stated in R.C. Chapter 3772;

**WHEREAS**, the Commission approved the initial filing of the following amended, rescinded, and new administrative rules:

**WHEREAS**, the Commission followed the rule-filing procedure, providing the agency with the authority to adopt the rules;

**WHEREAS**, the Commission considered the matter at its public meeting held on September 15, 2021.

**NOW, THEREFORE, BE IT RESOLVED** by the Commission that the amended, rescinded, and new rules are **ELIGIBLE** for adoption and final filing.

**BE IT FURTHER RESOLVED** that the rules are **ADOPTED** and staff is authorized and directed to **FINAL FILE** them in accordance with R.C. Chapter 119.
