 2. Table Promotional is the total amount of promotional gaming credit redeemed for table games.
 3. Slot Promotional is the total amount of promotional gaming credit redeemed for slot machines.
 4. # of Tables is the total number of table games reported by the casino operator on the last day of the reported month.
 5. Table Drop is the total amount converted to gaming chips on table games including Table Promotional.
 6. Table Revenue is total gross casino revenue from table games.
 7. Table Payout % is the percentage of Table Drop returned to patrons as winnings.
 8. # of Slots is the total number of slot machine games reported by the casino operator on the last day of the reported month.
 9. Slot Coin In is the total amount wagered on slot machines including Slot Promotional.
 10. Slot Revenue is total gross casino revenue from slot machines.
